New Zealand GST & PAYE Changes

We are not far away from when the new GST rate & PAYE takes effect. Earlier this month, we emailed out a 'GST Newsletter' offering clients the option of using a unique interface written specifically to assist in making the GST transition easier or alternatively make the changes manually without utilising the facility.
